PAYMENT, PERSONAL DATA AND INSURANCE - Terms of payment January 2024

EU citizens: At time of application you will receive your payment details. You will be charged monthly, one month in advance, throughout the course, in accordance with this overview. Please note; enrolment fee and the first rate of school fees should be paid prior to the course start as stated in the overview mentioned above.

Registration Fee: A registration fee of DKK 3.500,- (approx. 470,- EUR) is charged in connection with enrolment to every term. School fees: The price for attending Egå Youth Folk High School is DKK 1.595,- (approx. 215 Euros) per week before the deduction of state subsidies. The actual charge, therefore, amounts to DKK 1.295,- (approx. 174,- EUR) per week. The deduction of the state subsidies happens automatically and does not require any form of application from students or parents.

Outside the European Union: When you live outside the EU and need to apply for a VISA to study at a Folk High School, you have to pay the total amount* at once, before you can apply for VISA, and before the course starts. (*Registrations fee and School fees - according to the rules of the Danish immigration Service).

Payment details: Payments can be made to the school's bank account. Remember to include the students name in the transfer info and add additional bank fees to the price.

What is included: All fees and expenses concerning your stay at Egå Youth Folk High School are included in the monthly payment (accommodation, all meals, excursions, lessons, travel abroad, etc.).

Cancellation of registration: DKK 2.000,- (approx. 269,- EUR) of the enrollment fee will be refunded if you cancel your stay later than six months prior to the course start. If you cancel the registration later than 3 months prior to the course start, no refund will be made. If the student is denied a residence permit, the school will return the amount paid, except for the bank fee.

Smoking: It is not allowed to smoke on the school premises. If a student is caught smoking at school he/she will be fined DKK 500,- (approx. 67,- EUR)

Absence and expulsion: If you are absent from the school for a week or more, the subsidies from the state will not be deducted for this period, hence the full price of DKK 1.595,- (approx. 215,- EUR) per week will be charged. For any reason, if the stay is terminated, you will be charged for four full weeks DKK 6.380,- (approx. 857,- EUR) beyond payment for the time that you have actually been present. The stay is considered terminated when the room has been left cleaned and the key returned to the office. If you break school rules and are sent home to think things over, or if you are permanently expelled, you must cover the costs of your own transport and all other related costs, including accommodation.

The above-mentioned prices are valid at the time of writing and may be subject to change. The prices are estimates depending on the current exchange rate.

Insurance

Liability insurance: We recommend that you have liability insurance. If you cause an accident and are liable according to law, your insurance will cover it, if you have one. (If you damage the properties of the school or others, you will be held accountable).

Insurance of belongings: You should also have insurance covering your own belongings, for instance in case of theft. Most students will be covered by their parents' family insurance.

Personal accident insurance: It is also a good idea to have personal accident insurance that covers injury to yourself. Please confirm this with your own insurance company, in your own country, to make sure that you are insured in all circumstances.

Travel Insurance: The school has taken out travel insurance which covers the students during the school trip, but remember to bring the yellow and blue health insurance certificate (which you will receive after your residence permit is granted) or equivalent private coverage.

If the student suffers from illness, it is important that you yourself investigate whether a preauthorization is necessary. You can then contact SOS International phone +45 38 48 82 50 to inquire about the pre-approval procedure and to inform them the school's insurance company and policy number: *Risk Point - Police number 95952-16836*. If you have taken out travel insurance yourself, you can contact your own insurance company and get clarity on the procedure. If you get a full or partial rejection of a pre-approval and yet choose to go on the school trip, the financial risk is of your own expense and costs in this regard are not covered by the school.

Danish Health system: You are also able to become registered in the Danish healthcare system and get a yellow health insurance card. It is your own responsibility to obtain it. Please refer to the procedure sent to you by email, when enrolling. Transport to doctor the school will cover student travel expenses to/from the emergency room for acute injuries, but students must cover the costs when going to the doctor's office or for routine check-ups in hospital, etc.

Please notice that you need your own health insurance in the start of the course until you are registered in the Danish Health insurance system.

Consent to the Personal Data Regulation

We note that in connection with the usual administration of the stay at Egå Ungdoms-Højskole conducts electronic processing, including the obligation of disclosure, by the personal data required by Article 6 of the Data Protection Regulation on General personal data, Article 10 criminal records and, where applicable, Article 9 on special personal data.

With your agreement, you consent to, pursuant to Article 6 of the Data Protection Regulation. 1 point a, as well as Article 9 2 pts. a that we can process your personal information in order to meet Egå UngdomsHøjskole's obligations in relation to your stay and your attendance at school. In this connection, the disclosure of personal data could be: UU feedback (Ungdommens Uddannelsesvejledning) Denmark's statistics (Dansk Statistik) Ministry of Culture / Ministry of Education The school's auditor. Your consent also includes that we may use a picture for presentation of you on the school's intranet. The disclosure of your personal information beyond what is described above will require a new concrete consent. We will permanently delete personal information that is not required for us to fulfill our obligations in relation to your stay and your attendance at school. Deletion of personal information will be made according to the general limitation rules applicable in Denmark. If for some reason we have to keep personal information beyond the limitation period, we will inform you about it You can withdraw this consent at any time by sending us an email to: info@euh.dk with a message that you withdraw your consent. If you withdraw your consent, you must assume that it will mean that your stay at Egå Ungdoms-Højskole must be discontinued as Egå Ungdoms-Højskole will not be able to live up to its obligations as a Danish Folk High School.

Marketing:
